## Universal Design for Life

When someone says, "It is universally designed," she is talking about a custom-built house, correct? Maybe, but she could also be speaking of a museum display, or measuring cups, or a remote control, or even a microwave. It doesn't even have to be "custom-designed." It should be designed for all people to use immediately without modifications!

But how can a microwave be universally designed? By using the Seven Principles of Universal Design created at N.C. State University:

**Equitable Use:** Only one microwave exists that works for all people. Make a great microwave once, rather than making a different kind of microwave for every disability or having to add features such as speech recognition, Braille, or flashing lights.

**Flexibility in Use:** The microwave can be modified easily for people with unique needs. For example,

**Universal Design (cont.)**

it can be trained to recognize unique vocal patterns.

**Simple and Intuitive Use:** Do you need an engineering degree to operate the microwave? The designer should only require one button to be pressed at once, rather than combinations. Use fewer buttons to accomplish the same goals.

**Perceptible Information:** Create a usable interface so users don't have to guess what a button will do. Using symbols, pictures, words, beeps, and even verbal interface makes it most usable.

**Tolerance for Error:** Think about Daffy Duck or the Coyote hitting the wrong button. Exploding TNT, anyone?



**Low Physical Effort:** A user does not need to reach around, under, over, or through the microwave to make it work. It does not require strength, grasping, or pinching to operate.

**Size and Space for Approach and Use:** Can the user reach a reset button or the plug easily or are they jammed in the back of the unit?

Okay, enough about microwaves! What about homes? A home is universally designed if every member of a family, with or without disabilities, can use features in a home without specialization, modification, or assistance.

Won't that cost a lot of money? In some cases, yes, but in many cases, no, it will not. It just takes creative thought and looking at the issue from a solution-oriented attitude.

SAIL team members have given several presentations on universally-designed homes in recent months, sharing ideas ranging from pull-out drawers in cabinets to fist-operated light switches. SAIL pushed strongly for zero-step (no steps or ramps) construction and accessible bathrooms, a concept called visitability.



Visitability initiatives are sweeping the nation. Cities like San Antonio and Atlanta, along with several states, have passed laws to require homes and apartments built on city- or state-donated lands or tax breaks to be "visitable," or accessible to owners and visitors. Bolingbrook, Illinois, takes it another step, requiring all new homes to be accessible! Web Insights: Info Every Renter  
with a Disability Should Know

Renters with disabilities have the federal fair housing laws on their side. Did you know that you can legally make any change you need to your unit or request a reasonable accommodation to a policy?

You are required to ask your landlord for permission, but she can't say no! But any change made inside the unit must be restored to the original when vacating the property, unless your landlord says otherwise.

Any modifications made outside the unit can remain, if they add value to the unit like a well-designed ramp does. A landlord must modify a "no pets" policy to allow any type of service animal and can not charge a deposit for the animal.

If your landlord does not follow these laws, you can file a complaint at [www.hud.gov](http://www.hud.gov) or file a lawsuit with the assistance of Juneau's Disability Law Center. Contrary to ADA lawsuits, you may request damages from your landlord in a lawsuit under the Fair Housing laws. Read more at <http://www.hud.gov/offices/ftheo/FHLaws/yourrights.cfm>
